CONTRACT COMPLIANCE


The Tollway's Contract Compliance Team is responsible for monitoring all compliance requirements applicable to the following programs:

- Disadvantaged Business Enterprise (DBE): (49 CFR Part 26 & 23)
- Veteran Business Enterprise (VBE): (30 ILCS 500/45-57)
- State of Illinois Prevailing Wage requirements: (820 ILCS 130/)
- Equal Employment Opportunity (EEO) Program: Executive Order 11246 and by Title VII of the Civil Rights Act of 1964, the Illinois Department of Human Rights (IDHR) as established through the Illinois Human Rights Act (Illinois Compiled Statutes, 775 ILCS 5/1 -101, et sequitur), and State of Illinois Executive Order 15-2, Executive Order To Ensure Equal Opportunity Is Provided To All Illinois Persons And Businesses.



B2GNOW



- By the 15th of the month, all payment information from the Prime must be entered for all subcontractors on the jobsite in B2GNOW (including zero values).
- By the 25th of the month, all payment information for subcontractors/sub-tiers must be confirmed in B2GNOW (including zero values).

CAPTURE

- EEO information must be submitted in Capture no later than the 25th of the month for the prior month's payroll data.
- The prime is responsible for submitting EEO hours in the Tollway's Capture System. Prime contractors are responsible for ensuring that EEO hours including those of their subcontractors are reported in Capture for every construction worksite.

- The contractor is responsible for submitting certified payrolls to the Illinois Department of Labor (IDOL).
- Prime contractors are responsible for ensuring that certified payrolls including those of their subcontractors are submitted to IDOL, including all properly executed certifications, organized by contract for every construction worksite.
- Questions concerning the certified payroll submission should be directed to IDOL.



CONSTRUCTION

Reminders

- Ensure that Diverse and Non-Diverse vendors are set up in B2Gnow through the A15 process.
- Waivers of lien are required to be submitted via B2GNow for each pay estimate or retainage release application. Trailing lien waivers must be submitted within the 60-day threshold
- EEO Hours reporting will be completed in Capture.
- Prevailing Wage: Certified payroll submission will now be directed to IDOL and must be completed weekly.
- There will be unannounced periodic site visits to the jobsite.
- Company profile/user contact information for the Prime and Subcontractors should be reviewed periodically for updates Please notify your Tollway compliance analyst regarding any new changes/updates.



CONSTRUCTION

Expectations:

- By the 15th of the month, all payment information from the Prime must be entered for all subcontractors (diverse and non-diverse) on the jobsite in B2GNOW (including zero values)
- By the 25th of the month, all payment information for subcontractors/sub-tiers (diverse and non-diverse) must be confirmed in B2GNOW (including zero values)
- By the 25th of each month all EEO hour submissions should be completed in Capture.
- All Certified payroll should be entered into IDOL weekly.
- All changes to the Utilization Plans must be approved by Compliance including:
 - Subcontractor changes
 - Decreases in Subcontractor performance
 - Increases to the contract value

- By the 15th of the month, all payment information from the Prime must be entered for all subcontractors (diverse and non-diverse) on the jobsite in B2GNOW (including zero values)
- By the 25th of the month, all payment information for subcontractors/sub-tiers (diverse and non-diverse) must be confirmed in B2GNOW (including zero values)


