

 - Offers are to be submitted in seven (7) packets, all electronic packet title and content requirements are listed and detailed in the RFP.
 - Packet 1: Response to the Specifications/Qualifications/Statement of Work
 - Packet 2: Pricing
 - Packet 3: Offer and Applicable Forms
 - Packet 4: Forms A for non active registrants of the Illinois Procurement Gateway (IPG) –OR- Forms B for Offerors that have a valid IPG registration number with expiration date and elect to not use the forms found in Forms A.
 - Packet 5: Redacted copy of the Offer
 - Packet 6: Response to the Minorities, Women, and Persons with Disabilities participation requirements
 - Packet 7: Response to the Veteran Small Business (VSB) participation requirements
 - All electronic packet title and content requirements are listed and detailed in the RFP
