This cloud-based software will allow the Tollway to aggregate data from our Technical Assistance Program, ConstructionWorks, Earned Credit Program, Partnering for Growth, Small Business Initiative, and future Tollway programs into a single easy-to-use software. Functions include sending and receiving notifications to participants, providing communication to and from program participants and vendors, creating workflows, collecting metrics and data, running reports, and providing a dashboard for data evaluation. Implementation and support services will be provided by Pacific Point, a Salesforce.org Equality Partner. The amendment includes training of the Diversity Department staff, administration, training material for Business and Workforce clients, technical support, and system upgrades for the term of the contract.

The master contract being utilized (Contract AR2472) is between Carahsoft Technology Corporation and the State of Utah which issued a request for proposals on behalf of NASPO (National Association of State Procurement Officials) ValuePoint Cooperative Purchasing Organization participating states and their eligible end users. The CPO's Office established the ROMAMC master contracts from these cooperative contracts and the Tollway benefits from the negotiated prices.

The devices are critical pieces of equipment required to keep the roadway shoulders and live lanes of traffic clean of debris. In-cab operator controls and the articulating wing design of the LaneBlade® ensure safe capture, control, and removal of nearly any size highway debris from active travel lanes without putting roadway crews at risk.

Scope: The Finance Department recommends acceptance of a proposal for the Employee Life Insurance Benefits Program. Metropolitan Life Insurance Company (known as MetLife) has proposed to offer employer-paid basic life insurance at \$0.129 per \$1,000 of coverage and accidental death and dismemberment (AD&D) at \$0.02 per \$1,000 of coverage. The previous program offered identical benefits for a rate of \$0.10 per \$1,000 of coverage and a \$0.02 rate for the AD&D coverage. Employees will also be able to obtain optional insurance coverage at their own cost for spouses and children and voluntary AD&D coverage. The cost of optional coverages will be paid through a payroll deduction.

Request approval for three (3) years of coverage from 03/01/2025 through 02/29/2028 for a proposal obtained through the CMS Master Contract for insurance brokerage services with Mesirow Insurance Services, Inc. (Alliant Insurance Services, Inc.).

Description: IGA with the Illinois Department of Transportation (“IDOT”)

Scope: The Tollway is coordinating with IDOT on an IDOT-led project impacting I-39 and US Route 20 near Rockford, Illinois. The Tollway currently has jurisdiction over a portion of I-39 that is within the project limits. After the project is complete, the Tollway plans to transfer jurisdiction of its portion of the property to IDOT (pursuant to the provisions of the Tollway’s Excess Property Policy), which will serve to enhance roadway maintenance and efficiency to the benefit of the motoring public. As part of the project, the Tollway requested that IDOT remove and relocate an existing Tollway Dynamic Message Sign located near the NB I-39/I-90 interchange, which work IDOT agreed to perform. In view of the foregoing, the IGA sets forth, among other things, updated maintenance responsibilities relative to I-39, including responsibility for snow removal on US 20 ramps and a relocated turnaround used by both parties’ maintenance vehicles.

Amount: The estimated cost to the Tollway is \$974,671.00. The Tollway will reimburse IDOT for its actual costs.
