Description: Approval of the Fiscal Year 2025 Final Budget

Scope: The 2025 Final Budget allocates \$1,719.6 million of revenue as follows:

- The M&O Budget is \$470.6 million, an increase of \$19.3 million, or 4.3 percent more than the 2024 Budget of \$451.3 million.
- Revenues of \$537.3 million are allocated for transfers to the Trustee for Debt Service. These revenues, along with federal subsidies for Build America Bonds, will be utilized to meet debt service payments and related support costs.
- Revenues of \$711.7 million are allocated to the Renewal & Replacement and Improvement Accounts, providing a significant source of funding for the *Move Illinois* Program. These funds, together with bond proceeds, will be available to fund the Tollway’s \$1,147.3 million capital program costs anticipated in 2025.

Description: In April 2024, the Illinois State Toll Highway Authority (“Tollway”) established a Stakeholder Advisory Team (“SAT”) as part of the ongoing capital planning process. The SAT consists of 43 leaders representing non-profit, civic, business, labor, environment, transportation and advocacy organizations from across the Tollway region. The SAT’s responsibility is to serve as a representative body of the region and utilize the capital program’s four guiding principles— diversity, equity and inclusion, innovation, equitable economic development and sustainability—to provide guidance and input on the scope and impact of the next capital plan.

Over the course of eight months, the SAT held five meetings incorporating interactive activities and small-group discussions. The SAT also conducted a site visit to a Tollway maintenance facility and project site. In December 2024, the SAT produced a final report identifying priorities and actionable recommendations for the Tollway’s consideration in the next capital plan. This report was subsequently provided to Tollway leadership and members of the Board of Directors and will be considered by the Strategic Planning Committee as they formulate the next capital plan.
