Description: Approval of the Fiscal Year 2026 Final Budget

Scope: The 2026 Final Budget allocates \$1,785.5 million of revenue as follows:

- The M&O Budget is \$467.7 million, a decrease of \$3.0 million, or 0.6 percent less than the 2025 Budget of \$470.6 million.
- Revenues of \$581.9 million are allocated for transfers to the Trustee for Debt Service. These revenues along with federal subsidies for Build America Bonds will be utilized to meet debt service payments and related support costs.
- Revenues of \$735.9 million are allocated to the Renewal & Replacement and Improvement Accounts, providing a significant source of funding for the *Move Illinois* Program. These funds, together with bond proceeds, will be available to fund the Tollway's \$1,260.1 million capital program costs anticipated in 2026.

Reason: This construction change order/extra work order is for modification of pier construction and for additional piling installation. This work is required to coordinate rail operations with the Canadian Pacific Kansas City Southern (CPKC) Railroad. The installation of an additional track by CPKC within their Bensenville Yard requires modifications to an adjacent pier to prevent an impact to rail operations. The work includes modification of the pier foundation to allow construction to proceed. Also, for construction of other bridge piers, additional piling is needed for foundation construction due to underground site conditions differing from what was anticipated. The amount of the change order/extra work order is estimated and only actual costs will be paid.
