Scope: On June 22, 2020, The Illinois State Toll Highway Authority (“Tollway”) entered into an Intergovernmental Agreement with Lake County (“County”) that requires the Tollway to convey fee title to parcels TW-13A-19-001 & TW-13A-19-002 (collectively, “Parcels”) to the County for public purposes.

The Tollway acquired both parcels in November 2020 for improvements along I-94. TW-13A-19-001 is a .167-acre parcel located at the southwest corner of Stearns School Road between I-94 and North Creek Drive in Gurnee. TW-13A-19-002 is a .538-acre parcel wedged between the south side of Stearns School Road, the east side of I-94, and the west side of Lawson Boulevard in Gurnee.

On May 12, 2026, the Excess Property Committee determined that the Tollway (i) currently does not need the Parcels for toll highway or appurtenant purposes, (ii) does not need the Parcels in connection with the maintenance and operation of the Tollway System, (iii) has no presently planned use for the Parcels, and (iv) does not need the Parcels for any foreseeable improvement. Accordingly, Staff requests that the Board declare the Parcels excess property. Pursuant to said declaration, the Parcels will be transferred in accordance with the above-referenced IGA.

Scope: On August 9, 2000, The Illinois State Toll Highway Authority (“Tollway”) acquired permanent easement T-11A-41.1-PE2 (“Parcel”) for the construction, maintenance and inspection of a storm sewer from Walgreens Co. (“Walgreens”). On December 13, 2024, Walgreens sold property, including the Parcel, to Pulte Home Company, LLC (“Pulte”), which is developing the property for residential use.

For its development, Pulte needed to remove the Tollway’s storm sewer. Accordingly, in exchange for the Tollway allowing Pulte to remove the storm sewer and the Tollway’s agreement to release its right, title and interest in the Parcel, Pulte constructed a replacement storm sewer for the Tollway and agreed to grant the Tollway a permanent easement therefor designated parcel T-11A-41.1 PE-3 (“PE-3”).

On November 20, 2024, the Excess Property Committee determined that the Tollway (i) currently does not need the Parcel for toll highway or appurtenant purposes, (ii) does not need the Parcel in connection with the maintenance and operation of the Tollway System, (iii) has no presently planned use for the Parcel, and (iv) does not need the Parcel for any foreseeable improvement.
