

## RESOLUTION NO. 23145

**Background**

As set forth in Article III, Section 3 of the By-Laws of The Illinois State Toll Highway Authority (“Tollway”), the Board shall biennially select a Secretary and fix the Secretary’s compensation. The Secretary, or an Assistant Secretary, shall (i) be present at all board meetings, (ii) keep accurate records of those meetings, and (iii) have all necessary powers incident to the performance of the office and such other duties as from time to time may be authorized, ordered or directed by the Board or the Chairman.

Additionally, pursuant to Section 1.05 of the Open Meetings Act (“Act”), 5 ILCS 120/1.05, the Tollway must designate Tollway employee(s) to receive training on compliance with the Act and submit a list of its designees to the Public Access Counselor.

**Resolution**

Effective March 19, 2026, Christi Regnery is appointed Tollway Secretary. The Executive Director is hereby authorized to establish a reasonable salary for the Tollway Secretary. As Tollway Secretary, Ms. Regnery shall be responsible for the day-to-day management of Board-related matters, reporting to the Chairman and the Board of Directors, and shall perform all duties for the Tollway consistent with this appointment.

Effective March 19, 2026, the Tollway appoints Janet Long Assistant Secretary of the Tollway. Ms. Long shall have the authority to exercise all of the powers of the Secretary due to vacancy in the role of Secretary or as directed by the Chairman when the Secretary is unable or unavailable to perform certain duties ordinarily performed by the Secretary. No additional compensation shall be paid said individuals for performing the services of Assistant Secretary.
