#### ILLINOIS TOLLWAY AWARDS MORE THAN \$31.8 MILLION FOR CONSTRUCTION IN APRIL

Work in 2025 includes investments to maintain roadway and bridges on the Jane Addams Memorial Tollway (I-90)

**DOWNERS GROVE, IL –** The Illinois Tollway Board of Directors today approved three construction contracts totaling more than \$31.8 million at its April Board meeting, including contracts to maintain and improve roadway and bridges on the Jane Addams Memorial Tollway (I-90).

More than \$149.1 million in contracts has been approved by the Tollway Board in 2025, including \$113.8 million as part of the 14<sup>th</sup> year of the Tollway's 16-year, \$15 billion Move Illinois capital program and \$35.3 million as part of the first year of the 7-year, \$2 billion Bridging the Future plan. The Tollway's 2025 capital program calls for investing \$1.15 billion.

Overall, more than \$11.7 billion has been invested in capital improvements by the Tollway since 2012, with more than \$3.1 billion of that total committed to small, diverse and veteran-owned firms. In addition, the capital program has created or sustained an estimated 140,840 total jobs as of March 2025.

"The Illinois Tollway does an excellent job of maintaining our roads, bridges and facilities by conducting annual inspections and making repairs on a timely basis to protect our investment in the 294-mile system of roadways," said Illinois Tollway Executive Director Cassaundra Rouse. "Our commitment to infrastructure preservation not only extends the useful life of our roadways, but it also enables us to preserve our high level of service to our customers."

The April construction contract awards include:

- An \$11.1 million contract awarded F.H. Paschen, S.N. Nielsen & Associates, Chicago, IL, for pavement and structural rehabilitation and toll plaza improvements on the Jane Addams Memorial Tollway (I-90) between East Riverside Boulevard and Garden Prairie Road.
- An \$11.7 million contract awarded to Plote Construction Inc., Hoffman Estates, IL, for pavement and structural rehabilitation on the Jane Addams Memorial Tollway (I-90) between Garden Prairie Road and Randall Road.
- A \$9.1 million contract awarded to The George Sollitt Construction Co., Wood Dale, IL for facility improvements at the Central Warehouse and Sign Shop on the Reagan Memorial Tollway (I-88) and at the Downers Grove (M-14) Maintenance Facility on the Veterans Memorial Tollway (I-355).

The contract includes six certified disadvantaged, minority- and women-owned business enterprise (D/M/WBE) firms, as well as four certified veteran-owned firms. Commitments for D/M/WBE participation range from 20.14 percent to 24.47 percent per contract and commitments for veteran participation range from 2.18 percent to 6.53 percent per contract.

Construction contracts for Illinois Tollway projects are competitively bid under the rules of the Illinois Procurement Code. All contracts are presented to the Illinois Tollway Board of Directors for review and approval.

#### **About Move Illinois**

The Illinois Tollway's 16-year, \$15 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, is improving mobility, relieving congestion, reducing pollution, creating as many as 165,220 jobs and linking economies throughout the region. The first 13 years of Move Illinois are on schedule and within budget, delivering the new Illinois Route 390 Tollway and a rebuilt and widened Jane Addams Memorial Tollway (I-90) with its new SmartRoad corridor, as well as opening a new interchange connecting the Tri-State Tollway (I-294) to I-57. Progress continues on projects addressing the remaining needs of the existing Tollway system, delivering the new I-490 Tollway Project and reconstructing the Central Tri-State Tollway (I-294).

#### **About Bridging the Future**

Approved by the Illinois Tollway Board of Directors In December 2024, Bridging the Future is a seven-year, \$2 billion plan designed to continue infrastructure improvements, bridging the gap between the agency's current and next long-term capital program. Based on stakeholder feedback and engagement, Bridging the Future is addressing ongoing modernization initiatives and continuing to support investments in the people and firms working to improve regional mobility.

### **About the Illinois Tollway**

The Illinois Tollway is a user-fee system that receives no state or federal funds for maintenance and operations. The agency maintains and operates 294 miles of roadways in 12 counties in Northern Illinois, including the Reagan Memorial Tollway (I-88), the Veterans Memorial Tollway (I-355), the Jane Addams Memorial Tollway (I-90), the Tri-State Tollway (I-94/I-294/I-80) and the Illinois Route 390 Tollway.
