RAMP CLOSURES AND DETOURS SCHEDULED AT ILLINOIS ROUTE 31 INTERCHANGE ON THE JANE ADDAMS MEMORIAL TOLLWAY (I-90) FOR TOLL PLAZA WORK

Closures scheduled to continue into October for toll plaza improvements in Elgin


DOWNERS GROVE, IL – Ramp closures with a posted detours are scheduled to begin Sunday and continue into October for toll plaza improvements at the Illinois Route 31 Interchange on the Jane Addams Memorial Tollway (I-90) in Elgin.

Electronic message signs and construction signage will be in place in advance to alert drivers to the closure and detour. Up-to-date information will be posted on the Tollway website in the <u>Daily</u> Construction Alert. All work is weather dependent.

Beginning overnight Sunday, September 21, the ramp connecting northbound Illinois Route 31 to eastbound I-90 is scheduled to close for a week and a detour will be posted. The detour will route Illinois Route 31 traffic through the interchange ramps to access eastbound I-90. During the detour, drivers will not be charged for multiple tolls.



In addition, beginning Sunday, September 28, the ramp connecting westbound I-90 to northbound Illinois Route 31 is scheduled to close for a week and a detour will be posted. The detour will route traffic through the interchange ramps to access northbound Illinois Route 31. During the detour, drivers will not be charged for multiple tolls.



The extended closures are needed to accommodate the removal of the existing barrier walls and equipment followed by the installation of new tolling infrastructure. Construction work will also include ramp pavement and shoulder work, as well as electrical, lighting and signage improvements. Work is scheduled continue through 2026 at the toll plazas at the Illinois Route 31 Interchange, including a long-term detour of the ramp connecting westbound I-90 to southbound Illinois Route 31 in 2026.

Closures and detours are being coordinated with the Illinois Department of Transportation, Cook County, Kane County, and the City of Elgin, as well as local fire and police departments.

In 2025, the Illinois Tollway is making improvements at toll plazas systemwide to improve traffic flow and mobility. The scheduled improvements prioritize structural, safety and operational considerations. This work is part of the Tollway's 16-year, \$15 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, and the 7-year, \$2 billion Bridging the Future capital plan.

Work Zone Safety

Construction zone speed limits are in effect in all construction zones 24/7 and drivers should continue to watch for changing traffic patterns and use caution, especially when workers are present.

The Illinois Tollway reminds motorists that the "Move Over Law" requires motorists to change lanes or to slow down and proceed with caution when passing any vehicle on the side of the road with hazard lights activated. If you see flashing lights ahead, please move over or slow down.

Illinois State Police have zero tolerance for drivers speeding in work zones or for failure to comply with the Move Over Law. The minimum penalty for speeding in a work zone is \$250 with up to a \$25,000 fine and a 14-year jail sentence for hitting a roadway worker. Penalties for failure to slow down or move over for a vehicle on the shoulder with flashing lights includes up to a \$10,000 fine, 2-year suspension of driving privileges and jail time, in extreme cases.

About Move Illinois

The Illinois Tollway's 16-year, \$15 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, is improving mobility, relieving congestion, reducing pollution, creating as many as 165,220 jobs and linking economies throughout the region. The first 13 years of *Move Illinois* are on schedule and within budget, delivering the new Illinois Route 390 Tollway and a rebuilt and widened Jane Addams Memorial Tollway (I-90) with its new SmartRoad corridor, as well as opening a new interchange connecting the Tri-State Tollway (I-294) to I-57. Progress continues on projects addressing the

remaining needs of the existing Tollway system, delivering the new I-490 Tollway Project and reconstruction of the Central Tri-State Tollway (I-294).

About the Illinois Tollway

The Illinois Tollway is a user-fee system that receives no state or federal funds for maintenance and operations. The agency maintains and operates 294 miles of roadways in 12 counties in Northern Illinois, including the Reagan Memorial Tollway (I-88), the Veterans Memorial Tollway (I-355), the Jane Addams Memorial Tollway (I-90), the Tri-State Tollway (I-94/I-294/I-80) and the Illinois Route 390 Tollway.
