In the presentation, the scope of the project and of the Council was outlined, and the constraints, issues and opportunities along the corridor were discussed. The issues covered included congestion, flooding and stormwater, the use of technology and improving system access. The meeting concluded with a discussion over the guiding principles of the project.
