The Illinois Tollway is in receipt of your FOIA request for copies of the follow information:

- Your request is granted in part and denied in part as follows.

The Illinois Tollway relied on the exemption in 5 ILCS 140/7(1)(b) to redact individuals' personal addresses for the following reasons: private information, which by definition means unique identifiers,

including home address, 5 ILCS 140/2(c-5), is exempt from disclosure unless disclosure is required by another provision of this Act, a State or federal law or a court order.

The Illinois Tollway relied on 5 ILCS 140/7(1)(g) to exempt a portion of the records that contain financial information for the following reasons: “Trade secrets and commercial or financial information obtained from a person or business where the trade secrets or commercial or financial information are furnished under a claim that they are proprietary, privileged or confidential, and that disclosure of the trade secrets or commercial or financial information would cause competitive harm to the person or business, and only insofar as the claim directly applies to the records requested.” 5 ILCS 140/7(1)(g).

Please note that Joelle McGinnis, FOIA Officer, was responsible for the denials referenced herein. You have a right to have the denial of your request reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5(a). You can file your Request for Review with the PAC by writing to:

You also have the right to seek judicial review of your denial by filing a lawsuit in the State circuit court. 5 ILCS 140/11.

If you choose to file a Request for Review with the PAC, you must do so within 60 calendar days of the date of this denial letter. 5 ILCS 140/9.5(a). Please note that you must include a copy of your original FOIA request and this denial letter when filing a Request for Review with the PAC.

Please note that since the electronic files responsive to your request are too large to provide via email, the Tollway will provide these records on a CD. In keeping with the copying fees allowed by the Illinois Freedom of Information Act 140/6(b), the cost of copying these records onto a CD is \$5.00 if you want to pick the disk up at the Tollway or \$6.00 [\$5.00 plus \$1.00 postage and mailing envelope]. You can also send a blank CD to the Tollway with an envelope and postage and there will be no fee.
