Dear Ms. Garbrecht:

The Illinois Tollway is in receipt of your FOIA request for a copy of the certified payrolls pertaining to contractor Conin Contractor Service, Inc. Specifically, for contracts I-13-5665 I-13-4616, I-13-4171, I-13-5666, I-13-5659, I-13-4170, I-13-4630, I-13-4138 and I-13-4142.

We have completed the review of your request. Please note that we do not have records available for RR-13-4138 because Conin Contractor Services, Inc. did not perform work on this contract. The records for I-13-5659 are located off-site storage and require a payment of \$30 to retrieve those records.

Please note that there are responsive records available for contracts RR-13-4171, I-13-4630, RR-13-5665, RR-13-4170, I-13-4616, RR-13-4142, and RR-13-5666. These records, however, are too large to provide via e-mail. In keeping with the copying fees allowed by the Illinois Freedom of Information Act, 5 ILCS 140/6(b), the cost of copying these records onto a CD is \$2.00 [\$1.00 CD plus \$1.00 postage]. If requested, we can make these records available to be picked up and the postage fee would be waived.

Payments for both the off-site storage fee and/or CD can be made to the Illinois Tollway, Attn: FOIA Officer, 2700 Ogden Avenue, Downers Grove, IL, 60515. The records will be processed upon receipt of payment.

The Tollway has redacted private information including personal addresses and social security numbers. Individual's personal addresses and social security numbers are exempt under Section 7(1)(b) which allows the Agency to redact individuals' private information. " 'Private information' means unique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person." 5 ILCS 140/2(c-5)

Please note that Joelle McGinnis, Freedom of Information Officer, was responsible for the denials referenced herein. You have a right to have the denial of your request reviewed by the

You also have the right to seek judicial review of your denial by filing a lawsuit in the State circuit court. 5 ILCS 140/11.

If you choose to file a Request for Review with the PAC, you must do so within 60 calendar days of the date of this denial letter. 5 ILCS 140/9.5(a). Please note that you must include a copy of your original FOIA request and this denial letter when filing a Request for Review with the PAC.
