## Discussion of probable or pending litigation

---

**Administrative Real Estate Settlement Supplement – Groot Industries (Legal Item 2):** General Counsel provided a summary of an Administrative Real Estate Settlement Supplement relative to Parcel WA-3D-12-006, which includes a waste transfer and material recovery facility located in Elk Grove Village, IL. She stated that these real estate interests are needed in conjunction with the Elgin O'Hare Western Access ("EOWA") Project.

General Counsel recapped for Directors that in October 2019, pursuant to Resolution 21905, the Board of Directors approved expenditures of up to \$20,000,000.00 to acquire and fully satisfy acquisition and business relocation costs relating to the Groot facility. She stated that final acquisition and relocation costs total \$20,563,024.00, \$563,024.00 more than the previously authorized upper limit, but include significantly enhanced DBE commitments. General Counsel advised that the Legal Department recommends entering into a final settlement in an amount not to exceed \$20,563,024.00, which includes 34.45% DBE participation as opposed to the original proposed settlement of less than 2% DBE participation. She noted that staff is additionally requesting that parcel WA-3D-12-003.EX be declared excess to the Tollway's needs.

A Director requested confirmation the final settlement includes construction costs to rebuild the waste transfer and material recovery facility. General Counsel confirmed.

## Discussion of matters before a quasi-adjudicative body

---

Staff provided Directors with background on protests (seeking administrative reconsideration) filed with the State's Chief Procurement Officer ("CPO") by non-winning bidder Walsh Construction Company II, LLC on contract I-18-4704 and Lorig Construction Company on contract I-19-4491, both awarded at the March 26, 2020 Board of Directors meeting. Staff noted the bids received from these firms, although the low-bids on the contracts, were deemed non-responsive by the Tollway for failure to comply with diversity goals stated in the contracts.



Staff provided additional details on the disputed issue, particularly, notice and the timeliness of the request for administrative reconsideration. Staff reported that the CPO recently sustained the protests of both firms, noting that the Tollway failed to abide by the administrative reconsideration provisions of the solicitation. Additionally, the CPO instructed the Tollway to revise its solicitation language to state that companies may request administrative reconsideration after they receive written notice of “non-responsiveness.” Staff verified that the Tollway has complied with these instructions.

Staff further stated that in response to the CPO’s findings, administrative reconsideration would be given to both parties, and a meeting has been scheduled for each to meet with the Chief of Diversity. Staff noted the Tollway will review the firm’s diversity submissions and “good-faith efforts” to determine if they satisfied contract requirements. Staff explained that if after administrative reconsideration, the Chief of Diversity determines that the contractors satisfied the contract requirements relative to diversity goals, the Tollway will award the contracts to the protesting firms (the initial low bidder). If the Chief of Diversity determines the contractors failed to satisfy those contract requirements, and remain non-responsive, the Tollway will seek a final decision on non-responsiveness from the CPO.

Directors and staff discussed current procurement processes and timelines, potential changes, as well as communications with vendors regarding “good faith efforts” needed to comply with contract requirements relative to diversity goals. A Director requested that copies of the CPO’s protest findings be circulated to all Directors for review and further discussion. **Chairman Evans stated the CPO’s protest findings will be circulated post-meeting**, and he proposed that follow-up discussion occur during Executive Session of the August Board of Directors meeting.

### Directors discussed pending or probable litigation

---

General Counsel provided a summary of the lawsuit filed against the Tollway in August 2019 by the Teamsters Health and Welfare Fund and Legal & Educational Assistance Fund, claiming insufficient contribution payments and unpaid past and future contributions. She advised the Board that in December 2019, the Tollway filed a motion to dismiss Plaintiffs' complaint and the court subsequently dismissed one of the three counts. She reported that the Tollway has since filed a motion for partial reconsideration of the Order allowing Plaintiffs' remaining two counts to stand. She noted that in addition, the Tollway filed requests to admit that highlight contractual provisions which should be interpreted to preclude the Tollway from having to make contributions to Plaintiffs and a related motion. General Counsel stated that the Tollway is currently awaiting rulings on both motions. General Counsel also stated that the Tollway notified Plaintiffs of its intent to terminate their contracts, thereby capping potential exposure for future benefits contributions beyond March 2021 or, potentially, earlier.

General Counsel then provided an update on an ongoing dispute between the Tollway and Mythics, Inc., an Oracle reseller, concerning support service fees for Oracle products. She explained that the Tollway believed it had entered into a multi-year agreement to pay Mythics, Inc. for support services for year one of the multi-year agreement, an additional payment during year two, with a significant reduction in fees in year three and beyond. She noted that in year three, however, the vendor sought to charge the Tollway \$1.5 million for support fees, a sum markedly in excess of what was originally agreed. She advised the Board that analysis of the contractual documents, validated by outside counsel, offer support for the Tollway's position in this matter. General Counsel expressed her hope that the substantive legal arguments developed and shared with the vendor's counsel will foster good faith negotiations during upcoming discussions and avoid potentially lengthy and costly litigation.

General Counsel noted that under the current extension agreement with the vendor, the Tollway's right to support services will expire on December 31, 2020, and because the Tollway cannot prudently forego support services (even temporarily), the Tollway will likely be seeking authority

## Directors discussed land acquisition activities

---

**Identification of Real Estate Parcels (Legal Item 2):** Pursuant to the Tollway's obligation (arising from *ISTHA v. DiBenedetto*, 275 Ill. App. 3d 400, 405 (1st Dist. 1995)) to identify real estate interests it may need to acquire by condemnation, General Counsel provided a summary table for the Central Tri-State Tollway (I-294) Project parcel identification report, noting the addition of seventeen (17) parcels.

## Directors discussed the Toll Violation Payment and Settlement Guidelines

---

General Counsel reminded Directors that on May 21, 2020, the Board extended the expiration date of the Tollway's Settlement Guidelines to May 1, 2022. She noted, however, that the Tollway subsequently implemented an amnesty program to provide needed relief to Tollway patrons experiencing financial hardship due to the current pandemic and/or other circumstances and rolled out *Tolling 2020* - a comprehensive tolling reform package that significantly reduced the initial costs faced by motorists who fail to pay their tolls. General Counsel further stated that for the June 25, 2020 through December 30, 2020 period in which the Tollway's amnesty program will be in effect, the Tollway suspended the Settlement Guidelines.

General Counsel explained that in view of *Tolling 2020*, the Tollway needs to further extend the suspension of the Settlement Guidelines because they are inconsistent with the invoicing model on which *Tolling 2020* is based. She advised the Board that it is in the best interest of the Tollway to generally and indefinitely continue the suspension of the Settlement Guidelines and remove the Guidelines from the Tollway's website.

---
