## **OVERNIGHT RAMP CLOSURES AND TRAFFIC SHIFTS CONTINUE IN FEBRUARY AS PART OF WORK TO RECONFIGURE THE I-290/I-88 INTERCHANGE AT THE TRI-STATE TOLLWAY (I-294)**

*Ongoing temporary closures needed to safely accommodate bridge reconstruction in the winter*

**DOWNERS GROVE, IL** – Overnight and long-term ramp closures with detours will continue throughout February as part of the Illinois Tollway's ongoing work to reconstruct and reconfigure the I-290/I-88 Interchange at the Tri-State Tollway (I-294). Delays are expected.

In February, the Tollway is preparing to shift northbound I-294 traffic between the Cermak Toll Plaza and the Reagan Memorial Tollway (I-88) with lane closures over multiple nights and ramp detours needed to shift traffic.

The traffic shifts are necessary to improve the flow of traffic and to provide a safe work zone for ongoing pavement and bridge reconstruction and widening, noisewall construction, drainage and utility work.

Construction and electronic message signs will be put in place in advance to alert drivers to the ramp and lane closures and detours. Up-to-date closure information will be available on the [Daily Construction Alert](#). All work is weather dependent.

Throughout February, ongoing temporary overnight ramp closures with posted detours will continue as needed at multiple interchange ramps connecting the Tri-State Tollway (I-294) to I-290, Reagan Memorial Tollway (I-88) and Roosevelt Road for ongoing pavement repairs, protective shielding, bridge reconstruction, pavement removal and utility work. ### **February Interchange Construction Highlights**

In February, work is scheduled to begin to shift traffic on northbound I-294 between the Cermak Toll Plaza and the Reagan Memorial Tollway (I-88). Once the traffic shifts are complete, three lanes will continue on northbound I-294 with the fourth lane exiting to eastbound I-290. To complete this work, multiple nights of overnight lane and ramp closures on northbound I-294 will be scheduled between 9 p.m. and 5 a.m. the following morning, as needed.

In addition, closures and detours of the ramps connecting northbound I-294 to Roosevelt Road (Illinois Route 38) in both directions will be needed during the roadway closures. Traffic will be detoured to eastbound I-290 to southbound Mannheim Road to access eastbound and westbound Roosevelt Road.



Also in February, temporary, overnight closures are scheduled on Butterfield Road under I-294 in Berkeley and Hillside for I-294 bridge beam removal. Multiple nights of intermittent, full closures, each lasting up to 15 minutes, will be scheduled in both directions on Butterfield Road.

Ramp and local road closures in this area are being coordinated with the Illinois Department of Transportation, Village of Berkeley, Village of Hillside, City of Elmhurst, Village of Oak Brook and Proviso Township, as well as local fire and police departments.

In 2026, work at the I-290/I-88 Interchange at I-294 will include ongoing reconstruction of I-294 bridges over I-88, Butterfield Road, the Canadian National Railroad, I-290 and Electric Avenue. It also includes reconstruction of the I-290 eastbound and westbound bridges over Electric Avenue, and the ramp from southbound I-294 to westbound I-88, the ramp from westbound I-290 to St. Charles Road and northbound I-294 as well as continued noisewall, retaining wall, pavement, drainage, electrical and lighting improvements.

The \$4 billion Central Tri-State Tollway (I-294) Project is reconstructing and widening the roadway between Balmoral Avenue and 95th Street to provide congestion relief, update old infrastructure to meet current and future transportation demand and address regional needs. This work is part of the Tollway's *Move Illinois* capital program. More than 220,000 vehicles use the Central Tri-State Tollway daily.

### Work Zone Safety

Construction zone speed limits are in effect in all construction zones 24/7 and drivers should continue to watch for changing traffic patterns and use caution, especially when workers are present. On I-294, a 45 mph work zone speed limit is in effect throughout the construction season.

The Illinois Tollway reminds motorists that the "Move Over Law" requires motorists to change lanes or to slow down and proceed with caution when passing any vehicle on the side of the road with hazard lights activated. If you see flashing lights ahead, please move over or slow down.

Illinois State Police have zero tolerance for drivers speeding in work zones or failure to comply with the Move Over Law. The minimum penalty for speeding in a work zone is \$250 with up to a \$25,000 fine and a 14-year jail sentence for hitting a roadway worker. Penalties for failure to slow down or move over for a vehicle on the shoulder with flashing lights include up to a \$10,000 fine, 2-year suspension of driving privileges and jail time, in extreme cases.

#### **About *Move Illinois***

The Illinois Tollway's 16-year, \$15 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, is improving mobility, relieving congestion, reducing pollution, creating as many as 165,220 jobs and linking economies throughout the region. The first 14 years of *Move Illinois* delivered the new Illinois Route 390 Tollway and a rebuilt and widened Jane Addams Memorial Tollway (I-90) with its new SmartRoad corridor, as well as opening a new interchange connecting the Tri-State Tollway (I-294) to I-57. Progress continues on projects addressing the remaining needs of the existing Tollway system, delivering the new I-490 Tollway Project and reconstructing the Central Tri-State Tollway (I-294).

#### **About the Illinois Tollway**

The Illinois Tollway is a user-fee system that receives no state or federal funds for maintenance and operations. The agency maintains and operates 294 miles of roadways in 12 counties in Northern Illinois, including the Reagan Memorial Tollway (I-88), the Veterans Memorial Tollway (I-355), the Jane Addams Memorial Tollway (I-90), the Tri-State Tollway (I-94/I-294/I-80) and the Illinois Route 390 Tollway.
