**LANE REDUCTIONS AND TRAFFIC SHIFTS SCHEDULED ON THE TRI-STATE TOLLWAY (I-294)  
AT BOTH 75<sup>th</sup> STREET AND 95<sup>th</sup> STREET INTERCHANGES**  
*Toll plaza improvement work scheduled to continue into 2027*

**DOWNERS GROVE, IL** – Lane reductions and traffic shifts are scheduled to begin this week at both the 75<sup>th</sup> Street Interchange and 95<sup>th</sup> Street Interchange on the Tri-State Tollway (I-294) for toll plaza improvements and pavement repairs, which will allow for better traffic flow and operations.

Electronic message signs and construction signage will be put in place in advance to alert drivers to the lane closures and traffic shifts. Up-to-date information will be posted on the Tollway website in the [Daily Construction Alert](#). All work is weather dependent.

Extended lane reductions and traffic shifts are scheduled to continue through the end of the year at both interchanges to accommodate the removal of the toll plaza canopies and barrier wall, as well as the installation of new monotubes and tolling infrastructure. Construction will also include ramp pavement and shoulder work, as well as electrical, lighting and signage improvements.

On Wednesday, April 1, the ramps connecting southbound I-294 to 75<sup>th</sup> Street, 75<sup>th</sup> Street to northbound I-294 and northbound I-294 to 95<sup>th</sup> Street are scheduled to be reduced to a single lane for work at the toll plaza. Later this year, an overnight detour may be scheduled at the 95<sup>th</sup> Street Interchange for toll equipment installation.

Closures and detours are being coordinated with the Illinois Department of Transportation, as well as local fire and police departments.

The Illinois Tollway is making improvements at toll plazas systemwide to improve traffic flow and mobility. The scheduled improvements prioritize structural, safety and operational considerations. This work is part of the Tollway's 16-year, \$15 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, and the 7-year, \$2 billion Bridging the Future capital plan.

## **Work Zone Safety**

Construction zone speed limits are in effect in all construction zones 24/7 and drivers should continue to watch for changing traffic patterns and use caution, especially when workers are present.

The Illinois Tollway reminds motorists that the "Move Over Law" requires motorists to change lanes or to slow down and proceed with caution when passing any vehicle on the side of the road with hazard lights activated. If you see flashing lights ahead, please move over or slow down.

Illinois State Police have zero tolerance for drivers speeding in work zones or failure to comply with the Move Over Law. The minimum penalty for speeding in a work zone is \$250 with up to a \$25,000 fine and a 14-year jail sentence for hitting a roadway worker. Penalties for failure to slow down or move

over for a vehicle on the shoulder with flashing lights includes up to a \$10,000 fine, 2-year suspension of driving privileges and jail time, in extreme cases.

### **About Move Illinois**

The Illinois Tollway's 16-year, \$15 billion capital program, *Move Illinois: The Illinois Tollway Driving the Future*, is improving mobility, relieving congestion, reducing pollution, creating as many as 165,220 jobs and linking economies throughout the region. The first 14 years of *Move Illinois* delivered the new Illinois Route 390 Tollway and a rebuilt and widened Jane Addams Memorial Tollway (I-90) with its new SmartRoad corridor, as well as opened a new interchange connecting the Tri-State Tollway (I-294) to I-57. Progress continues on projects addressing the remaining needs of the existing Tollway system, delivering the new I-490 Tollway Project and reconstructing the Central Tri-State Tollway (I-294).

Approved by the Illinois Tollway Board of Directors in December 2024, Bridging the Future is a seven-year, \$2 billion plan designed to continue infrastructure improvements, bridging the gap between the agency's current and next long-term capital program. ### **About the Illinois Tollway**

The Illinois Tollway is a user-fee system that receives no state or federal funds for maintenance and operations. The agency maintains and operates 294 miles of roadways in 12 counties in Northern Illinois, including the Reagan Memorial Tollway (I-88), the Veterans Memorial Tollway (I-355), the Jane Addams Memorial Tollway (I-90), the Tri-State Tollway (I-94/I-294/I-80) and the Illinois Route 390 Tollway.
