The Illinois Tollway is giving notice of intent to extend contract 16-0013 Out-of-State Registration Retrieval Services with Law Enforcement Systems, LLC ("LES") for two- month period.

This contract will continue to support the collection of violation revenue by delivering vehicle registration information to pursue toll violators with license plates registered outside the State of Illinois. No additional funds being added for this extension.

The initial term award amount was \$750,000.00. \$424,878.75 was spent at the time of creation of this notice. The indicated award value is the difference between the original award and the amount spent or in process to date. This notice is not intended to reflect any additional funding being added.

All funding associated with the initial term remains without change.
