Subject to approval by the Tollway's Board of Directors, the Illinois Tollway is giving notice of intent to award contract 17-0018 Automotive Body Shop Repairs, Vehicle Painting, and Replacement Parts to Ward Auto Body, Inc.

This contract provides a source for the purchase of full-service crash repair (body and frame) and painting services for all types and sizes of Tollway-owned automobiles, sport utility vehicles, vans, and light-duty trucks.
