Teaming Vs. Joint Ventures



Teaming VS Joint Ventures

Teaming consists of a Prime Contractor / Subcontractor Relationship.

Joint Ventures are companies numbering two or more, proposing to perform as a prime contractor, in which each partner contributes property, capital, efforts, skill and knowledge, is responsible for a distinct, clearly defined portion of the work and of the project, and has a proportional share in the capital contribution, control, management, risks, and profits.

TYPES OF TEAMING

- Prime Contractors can pool their resources bringing together any combination of the following:
 - Subcontractors
 - Joint Venture Partners
 - Suppliers
 - Rental Vendors
 - Professional Services Consultants





SCOPES

- Specialty Subcontractors
- Partial work items
- Rental equipment, forms, traffic control devices, etc...
- Material Supply
- Engineering and Design Services

IDOT Subcontractor Listing	Approved Subcontractors	Contractors of any tier must be an approved IDOT subcontractor at the time of subcontractor approval submission on the Illinois Tollway System
Illinois Tollway SBI Registered Vendor Directory	Registry includes Contractors (Primes & Subcontractors) who have applied and are approved for SBI Bid Opportunities	Contractors of any tier on an SBI Opportunity MUST be in the Illinois Tollway's registry
Illinois Tollway Bid Opportunity Planholders List	Include Prime Contractor Planholders AND Technical Assistance Agencies for each open bid opportunity	This reference gives you a direct line to who is looking at the project and streamlines your connection to Assist Agencies

Tollway Technical Assistance Program Providers	The Tollway's Technical Assistance Program helps small and diverse firms build capacity to work on the Tollway's System	The Tollway Program's TA's have a large pool of Prime and Subcontractors that are often bidding and looking to Team on active open procurements
Illinois Procurement Gateway (IPG)	IPG Approved Vendor Directory	Construction, Engineering and Professional Service Firms in Illinois, including NIGP code(s) and if they are a Small Business Set Aside (SBSP) registered firm
Illinois Tollway Board and Committee Notices and Meeting Agendas	Archives of the Illinois Tollway's Board Meetings	Contractors can utilize this information to locate teaming partners who are on active or recently awarded Tollway contracts
Illinois Tollway Bid Tabulations	Provides bid tabulations of contract lettings by month and year	Allows for Contractors to find teaming partners that bid Tollway opportunities, apparent low and other bidders



Keep in mind, the Illinois Tollway considers the following certifications eligible for inclusion in a contract's DBE Plan:

- DBE
- WBE
- MBE

Only firm certified by the IL UCP are eligible to be considered for contract award to either meet the contract goal. Acceptable Certifying Agencies are as follows:

- City of Chicago
- County of Cook
- Small Business Administration

Sample Contract Scenario:

Advertisement Classification and Cost Magnitude:

Advertised as: SBI Tier 2 (\$1-\$3 Million Dollars)

Scope:

•Critical: Pour overhead sign foundations, fabricate and erect signs

- •Supplementary:
 - o Traffic Control
 - Specialty Electrical
- Contractor Classification: Specialty Sign Contractor
- Bidding as: Prime Contractor
- Registrations Required: IPG, SBSP, SBI, IDOT Subcontractor Approval

CHALLENGE	POTENTIAL SOLUTION(S)
Satisfying the DBE Goal (Vendors)	Utilize the collaboration resources referenced in this presentation, namely – contact the IL Tollway's TA Providers for Referrals
Satisfying the VOB Goal (Scope)	Consider trucking, aggregate supply, crane rental with operator, professional services consultants for Quality Control and/or design elements of the work
Lack of SBI Approved Electrical firms who can perform specialty electrical work (lack of capital, experience and equipment)	The prime can discuss the work scope in depth with the SBI subcontractor and offer partial participation utilizing their material relationships and heavy machinery, thus softening the financial burden of the subcontractor and relieving concern of lack of experience

- Small Business Initiative (SBI)
- Small Business Set Aside (SBSA)
- Self Performance (35% Standard)

- Capacity
