NOTE: The procurement of professional services is subject to the provisions of the Architectural, Engineering and Land Surveying Qualifications Based Selection Act, 30 ILCS 535/1, et seq. Firms meeting the qualifications for a professional services solicitation included in a Professional Services Bulletin may submit a statement of interest for the solicitation irrespective of whether they have provided such services or substantially similar services under any prior or existing contract (including renewals).

As set forth in Section 20-60(a) of the Procurement Code, 30 ILCS 500/20-60(a), the term of any one contract is authorized for a maximum of 10 years. Firms providing services under a prior or existing contract (including renewals) are not precluded from providing the same or

similar services under a subsequent contract, regardless of the length of the prior or existing contract (including renewals).

Notwithstanding the foregoing, a firm that is currently providing services under a Program Management Office (PMO), Consulting Engineer (CE), or Traffic Engineer (TE) contract cannot provide any new services to the Tollway during the term of its PMO, CE or TE contract. Publication dates, number of contracts and type of work is subject to change.
